Rule 14 The ³ report in Annex A The final ³ report to be adopted Potential adopters shall submit an application to the court, which shall issue instructions requiring iu Childraa s Trust to produce a report The timing of the application to the court is a quest for the prospective adopters Ae the Chileans Trust cannot prevent them if they intend to apply, and cannot insist that they apply if they do not feel ready. The s³ team can clarify their concerns ius and try to persuade them. If iu s instructions do not specify a specific time limit for this report, it shall be provided within 6 weeks ³ iu the date on which the instructions were issued. Biological parents may appeal against the decision to ³ their consent. The potential must pay an application fee, but may be entitled to some all the rate. There must be a clear agreement on the responsibility of drafting the final report and submitting it to the courtA s officeA s social workerA s responsibility or the potential social worker of the adopterA s social workerA s A A A Adopters fill out the registration form with the support of their social worker. However, at this stage, they can ask the court to oppose the application for adoption. At a later stage, a request may be made for the "opinion hearing" to be transferred to a court convenient for the adopters. SCOPE OF THIS CHAPTER This policy applies only when the Children's Trust has placed the child for adoption. The court may issue further instructions, for example on attempts to identify and contact the child's parents. Note that this does not necessarily mean 10 weeks after the placement for adoption: if the claimants were formerly the child's caretakers, they could appeal to the court immediately. However, it is unlikely that potential adopters would want to apply so quickly, and the Children's Trust would strongly advise against this. Staff should be aware that this report is specified in Annex A and is not the same as the report required under Regulation 14 and Annex B (report submitted in the application for placement). If there are serious concerns about the feasibility of the agreement, such that the well-being of the child appears to be at risk, staff should consider that the deployment is at risk of disruption. result in a decision regarding wasted costs.
